From the Advocate



Last month, I met a tech investor from Israel visiting California on a mission for his firm. His trip and the event we were both attending just happened to coincide with the Silicon Valley Bank closure and the federal intervention to secure its deposits. So I asked him, considering the headlines, if he was second-guessing his California scouting trip. "Oh no," he shrugged. "Israel is the Startup Nation. But this is California. The ecosystem here is like no other place."

Silicon Valley has ruled as the world's #1 startup ecosystem since 2017 in <u>a</u> widely quoted report from Startup Genome, ranking #1 in every evaluated category: Performance, Funding, Connectedness, Market Reach, Knowledge and Talent. In the 2022 report, Los Angeles ranks #6 and San Diego #13. (Tel Aviv is #7.)

This is why Pitchbook reports that California has received over 51 percent of all venture capital invested in the United States since 2000.

But that's no excuse to take California's dominance for granted or to stop pushing the envelope, two things Governor Newsom has consistently refused to do. Instead the Newsom administration is investing in the State's innovation ecosystem, leveraging that success and know-how so obvious to my new friend from Israel.

The latest example coming out of my office is called Accelerate California and it's designed to expand the reach of that California ecosystem to include more diverse founders, support new technology sectors, drive growth and create high-quality jobs in geographies beyond the coastline.

Grant Programs

Employment Social Enterprise Grant Programs Proposals Accepted Through May 8, 2023 The Employment Social Enterprise (ESE) Solicitation for Proposals for Program Year 2022-2023 grants will be awarded to design, develop, and implement programs that will promote job training opportunities and transitional employment through social enterprise programs for the hardest-to-serve individuals to provide economic self-sufficiency and life stability. The ESE will focus on the first step to transitioning participants into the workforce by placing individuals into employment, typically in a supported employment setting, to help them earn wages while building work experience, improving job skills as well as provide supportive services for California's most vulnerable populations.

Eligible applicants are ESE businesses or ESE providers collaborating with the public workforce development system and human service partners, public and private non-profit organizations, and community-based organizations are eligible to apply. Individuals are not eligible to apply.

Proposals must be received by 3 p.m. on May 8, 2023.

Mom-Preneurs, This Founders First CDC Grant Is for You

The Kitty Fund makes small micro investments in moms who are running employer-based small businesses with two or more employees. The award was created in honor of Mother's Day and Founder's First CEO Kim Folsom's mother, Catherine "Kitty" Abrams Tadlock Webster, who passed away in March of 2020.

For 2023, this \$25,000 fund will make investments of \$1,000 to 25 mother-led business owners in the form of grants. The deadline to apply is April 17, 2023.

San Bernardino County Mountain Small Business Grant Program



This program aims to assist small businesses and non-profits that were impacted by the winter storm events in San Bernardino County. Eligible small businesses and non-profits located in unincorporated areas of the County can apply.

- Businesses with 50 or fewer full-time employees are eligible for a onetime \$3,000 grant
- Businesses with a workforce greater than 50 but fewer than 500 employees are eligible for a one-time \$15,000 grant
