CalOSBA's monthly newsletter features the most recent announcements from the State of California, along with resources available for all small businesses across our diverse communities.




#### Governor Gavin Newsom Promotes CA Comeback Plan.

Just before many Blacks across the state were set to celebrate Juneteenth, CalOSBA Director Tara Lynn Gray joined Governor Newsom in Oakland to promote his <u>California Comeback Plan</u> which adds another \$1.5billion to the CA Relief Grant program which has helped thousands of small businesses in the state. The additional funds will make this the largest program of its kind in the nation.

Cathy Adams, President of the Oakland African American Chamber of Commerce, gave remarks in support of the Governor's plan and represented the positive sentiments of Black business owners in the city: more financial resources for small businesses are needed for economic recovery. With Ms Adams were Beast Mode Barbershop and Graffiti Pizza business owners. Other officials speaking that day include State Senator Nancy Skinner, Oakland Mayor Libby Schaaf, and Alameda County Supervisor Wilma Chan.
